SPECIAL TOWN MEETING OF ELECTORS

The Special Town Meeting of Electors was called to order by Chairman Warner at 7:02 p.m. on Tuesday, November 9, 2021. In attendance were three board members, plus twelve residents and one non-resident. Clerk had posted notices on the Town Hall door, the Town Website, two additional places within the Town, and in the Colfax Messenger.

To consider the adoption of a resolution by the town meeting endorsing the town board resolution R-03-2021 which proposes that the town levy exceed the state allowable levy limit under s. 66.0602, Wis. Stat., specifically a proposed tax levy which would exceed the allowable town tax levy for 2021 by 14.7 percent, for a dollar increase of \$16,970.

Results of voting: 7_Yes 8_No

Warner explained some of the background on the DOT program. We are lower on our expenses than any of the surrounding townships, except for Peru Township. We have had the same tax levy amount for many years. Further discussion held.

Motion to open voting by Ralph, second by Warner, voting by a show of hands was selected by the attendees rather than paper vote, motion passed. Results of voting were to **NOT** approve adoption of the resolution to exceed the levy limit, voting results 7 aye, 8 no. Motion to adjourn the special town meeting of electors at 7:13 p.m. by Ralph, seconded by Hayes, motion approved.

SPECIAL TOWN MEETING

The Special Town Meeting was called to order by Chairman Warner at 8:05 p.m. on Tuesday, November 8, 2021. This year's allowable tax levy for Otter Creek is \$115,221, an increase of 2.002% for new construction, as compared to \$113,213 in 2020, as allowed by the State of Wisconsin. With adding on current debt of \$14,442, the total 2021 levy payable in 2022 is \$129,663.

Ralph made a motion to accept the 2021 Town Tax Levy as \$129,663 allowable figure to be used in the 2022 budget pursuant to Section 60.10(1)(A) Wis. Stats. Hayes seconded the motion, motion carried. Opposed – 0.

Warner asked for a motion to adjourn the Special Town Meeting at 8:06 p.m. Ralph made a motion to adjourn, Hayes seconded the motion. Motion carried.
