The Regular Town Board meeting was called to order by Town Chairman, Mark Warner, at 7:03 p.m.

Approval of Minutes from the September 13, 2022 Regular Town Board Meeting. Motion by Ralph to approve the minutes of the 9/13/22 Regular Town Board Meeting, second by Hayes, MC. Motion by Ralph to approve the minutes of the 10/7/2022 Special Town Board Meeting to approve truck sale, second by Warner, MC.

Set date for Budget Meeting; Special Town Board meeting to adopt the 2022 tax levy to be paid in 2023; Regular Town Board Meeting. Due to the 2nd Tuesday of November as an election day, Nov. 8, 2022, the meetings noted above will be held on Nov. 15, 2022.

Act on request for stay of fence building submitted by Deringers. After a discussion, the board will issue the stay until November 14, 2022. If a Notice of Claim is filed, the Town Board will have 120 days to act on the Notice and the stay is extended to allow action on the Notice and other actions. Motion to grant the stay until November 14, 2022 made by Ralph, second by Warner, all in favor. MC. Clerk to notify Lori Sudbrink of the stay granted by the board.

Change in Drug Testing – DC meeting 11/4/22. Clerk Bernier will attend.

MFL withdrawal – Jonathan Wiesner paid the Clerk \$2,414.06. Clerk Bernier will submit payment to the Wisconsin DNR.

Elvin Newhouse fire – paid \$500 received from insurance, \$20 personal pay, requesting to make \$20/month payments on balance of \$598 (30 months or 2.5 years). The Town Board is requesting:

- 1) Payment of \$100/month, waive interest, or
- 2) Payments of \$20/month, with 1.5% interest on monthly unpaid balance, per Otter Creek ordinance, until payment made in full.
