**Call to Order** regular board meeting at 7:27 p.m. by Chair Ralph.

**Approval** of Minutes from the August 12, 2025 Regular Board Meeting. Motion by Bernier to approve, Ralph second, MC.

**Public Comments** - Public Comment is limited to 3 minutes. As per the state's Open Meetings law, there will be no back and forth discussion with the town board. The state Attorney General's guidance is that board members can ask clarifying questions but that back and forth discussion is not advised.

**Communication from Town Chair** – 2026 per capita for SW&R – about \$5,000 less. Board will apply surplus to operating, start replacing compactors. Starting to show some wear, spend about \$100,000 on compactors. \$26 to \$18/person. Colfax Rescue squad not met yet, not sure where the budget is.

### **Communication from Town Supervisors**

**Supervisor 1** – Nothing.

**Supervisor 2** – status update on cemetery sign, Jeff Dehnhoff, Bob Bernier, Bev Bernier, Renee Carrell sanded, new plywood, applied the front/back aluminum signs. Update on 1180<sup>th</sup> (Solheim road). Barry Wirth used the box blade on it. Going to get oil from Fleet Farm. Tractor – interest rates may be going down, clerk will check. Update on 730<sup>th</sup> – road material – start on north end and put 1 ½" rock on, 40 loads, Bob to contact Barry Wirth. Status of equipment: Brush Wolf, Rhino mower, trailer, backhoe.

- Wyatt Sell payment plan of \$236/month through December to pay off \$1180. Nothing received yet.

**Wyatt Sell request** – Wyatt is disputing the cost of repair due to his actions on April 2, 2025. No one present to dispute.

**2025 Levy – payable 2026 –** Discussion and possible revision of loan timeframe. 2025 levy was \$134,564. Loan for new tractor/mower, if paid in 5 years levy is \$145,094; if paid in 3 years levy is \$151,235. Interest for 5 years is \$7,650; if paid in 3 years interest is \$5,000. Savings of \$2,650. Carry over to October for discussion/decision.

**DNR – Forest Tax Law –** lands applied for 2026 MFL entry – 130 acres closed, 90 acres Bob Bernier, 40 acres Andy Johnson

**Consideration of purchasing or having a 10-foot box blade built.** Talked to Tainter Machine, about the same cost to build as to buy. Would replace the grader for grading roads. Looked at 1180<sup>th</sup>, the box blade did a great job. About \$7,000. Table to October meeting, Bernier will get pricing in the interim.

**Discussion and determination of cost for mowing town hall property.** Motion for \$75 for first time mowing, as cleanup of grounds was needed. \$50 for future mowing by Hayes, second by Ralph, MC.

**Discussion and determination of ordering salt/sand.** Albricht pit is \$15/ton in 2025. 11/23 received 383 tons @\$13.50/ton. Trucking from Lentz was 19 hours, or \$2,105. Table to October.

SUSPEND TOWN BOARD MEETING 8:05 PM – Motion by Ralph to suspend the regular town board meeting to finish out the BOR, second by Bernier, MC.

Motion by Ralph at 8:06 P.M. to reconvene the regular town board meeting, second by Bernier, MC.

**Discussion and determination of training plan for part-time road crew.** Dustin Kragness wants to look at what we have, plow, what does our grader blade look like, are the blades worn off? Faron and Terry want to come here and get a look at the equipment and see how it works. Get blades through the County. Get the Monroe dealer here along with Faron, Dustin, Terry, Cecil, Bob – Friday/Saturday. Authorize the clerk and supervisor 2 to set up a training date. Can leave the sander on for some of the year. Motion by Ralph, second by Hayes, MC.

**Discussion and determination on repair to town shop.** \$18,000 to repair, plus \$2,000 electrical. Motion by Hayes to proceed with building repair, Ralph second, MC.

**Discussion on proposed data center concerns.** Nothing that Otter Creek can do on this at this time.

**Discussion and determination on possible update to building ordinance** - to require a Land Use Permit for any accessory structure that is connected or will be connected to sanitary sewer or a Private Onsite Wastewater Treatment System (POWTS). Motion by Ralph to update the ordinance, second by Hayes. MC.
